Terms of Service for Healthcare Providers

Introduction

WellPrept™ is a productivity tool to help physicians and other healthcare providers improve patient outcomes while reducing provider burnout, by enabling the creation and publication of patient-facing websites containing biographical, medical and educational information. By registering as a WellPrept member or otherwise accessing or using any of our software or websites, including any related services (collectively, the “Service” or “Services”), whether as a registered member or an unregistered visitor, you are entering into a legally binding contract with WellPrept, Inc. (“WellPrept,” “we,” “us,” or “our”). The following Terms of Service (these “Terms”) govern your access to and use of the Service.

By accessing the Service, you acknowledge that you have read and understand these Terms, and that you agree to be bound by them. If you do not agree to be bound by these Terms, do not access the Service.

Eligibility and Activities

The Services are not intended or designed to attract children under the age of 18. We do not provide the Services to, nor do we collect personally identifiable information from, any person we actually know is a child under the age of 18. By accessing the Service, you agree you are a U.S. resident 18 years of age or older and a healthcare professional, providing content solely for individuals located in the United States. You also agree that any information you provide to us in connection with your account registration is accurate and complete, and that WellPrept may use such information to provide the Service or for any other purpose described in these Terms.

WellPrept is based in Lexington, Massachusetts, in the United States of America with principal offices in Lexington, Massachusetts. WellPrept makes no claims that the Service, any website created using the Services, or any content provided by WellPrept through the Service (the “WellPrept Content”) are appropriate or may be accessed or downloaded outside of the United States. Access to the Service, any website created using the Service, or any WellPrept Content, may not be legal by certain persons or in certain countries. If you access the Services or any website created using the Services (including any WellPrept Content contained therein) from outside the United States, you do so at your own risk and are responsible for compliance with the laws of your jurisdiction.

Subject to agreement to and compliance with these Terms, we grant you a limited, revocable, non-exclusive, non-sublicensable license to:

- Access and use the Services and WellPrept Content for the purposes described in these Terms.
- View or download a single copy of any website you create or publish using the Services, solely for your personal, noncommercial use.

Any other use is strictly prohibited and a violation of these Terms. If you violate any of these Terms and Conditions, your permission to use the Services and WellPrept Content automatically terminates and you must immediately destroy any copies you have made of any portion of the WellPrept Content not owned by you.

Privacy Policy

Your access to and use of the Service is also conditioned on your acceptance of and compliance with our Privacy Policy, which describes our policies and procedures on the collection, use and disclosure of your personal information when you use the Service. Subscription period

The Service or some parts of the Service are available only with a paid subscription. You will be billed in advance on a recurring and periodic basis (such as monthly or annually), depending on the type of subscription plan you select when purchasing the subscription.

At the end of each period, your subscription will automatically renew under the then current pricing, conditions, and terms, unless you or we cancel it prior to the renewal date.

Subscription cancellations

You may cancel your subscription renewal either through your account settings page or by contacting us at info@wellprept.com. You will not receive a refund for the fees you already paid for your current subscription period, and you will be able to access the Service until the end of your current subscription period.

Billing

By providing a payment method for your subscription, you represent that you are authorized to use that payment method for the associated purchase and you authorize us (or our third party payment processor) to charge your payment method for the total amount of your purchase (including any applicable taxes and charges). You shall provide us with accurate and complete billing information including full name, address, state, zip code, telephone number, and valid payment method information.

Should automatic billing fail to occur for any reason, you are solely responsible for resolving the payment issue and may not use the Service until it is resolved.

Fee Changes

We may modify the subscription fees at our sole discretion and at any time. Any subscription fee change will become effective at the end of your then-current subscription period.

We will provide you with reasonable prior notice of any change in subscription fees to give you an opportunity to terminate your subscription before such change becomes effective.

Your continued use of the Service after the subscription fee change comes into effect constitutes your agreement to pay the modified subscription fee amount.

Refunds

Except when required by law, paid subscription fees are non-refundable.

Free Trial

We may offer, at our sole discretion, a subscription with a “Free Trial” subscription for a limited period of time (the “Free Trial”). You may be required to enter your billing information in order to sign up for the Free Trial.

If you do enter your billing information when signing up for a Free Trial, you will not be charged by us until the Free Trial has expired. On the last day of the Free Trial period, unless you canceled your subscription, you will be automatically charged the applicable subscription fees for the type of subscription you have selected.

Timely payment in full is a condition to your continued access to and use of the Services. You agree that we may suspend or terminate your access to the Services in the event our fees and other charges are not paid in a timely fashion, and that nonpayment may be considered a breach by you of these Terms.

At any time and without notice, we reserve the right to (i) modify the terms and conditions of any Free Trial offer, or (ii) cancel such Free Trial offer.

User Accounts

When you create an account with us, you must provide us information that is accurate, complete, and current at all times. Failure to do so constitutes a breach of the Terms, which may result in immediate termination of your account on our Service.

You are responsible for safeguarding the password that you use to access the Service and for any activities or actions occurring with the use of your password, whether your password is with our Service or a Third-Party Social Media Service.

You agree not to disclose your password to any third party. You must notify us immediately upon becoming aware of any breach of security or unauthorized use of your account.

You may not use as a username the name of another person or entity or a name that is not lawfully available for use, a name or trademark that is subject to any rights of another person or entity other than you without appropriate authorization, or a name that is otherwise offensive, vulgar or obscene.

Content and Communications

Your Right to Post Content

Content Backups

We will provide support and attempt to troubleshoot any known or discovered issues that may affect the backups of content. But you acknowledge that we have no liability related to the integrity of content or the failure to successfully restore content to a usable state.

You agree to maintain a complete and accurate copy of any content in a location independent of the Service.

Copyright Infringement
